The past year has been one of challenges for all of us in animal welfare and veterinary medicine. Those challenges presented differing consequences, but ones that we rose to meet every single time. The determination, perseverance, and endurance needed this past year was demonstrated in the daily actions and interactions of the VBSPCA teams, volunteers, board members and loyal supporters. The tough times were met with resilience and buffered by numerous celebrations of joy - all for the animals.



Last year was complicated for pet owners in our community as veterinary staffing shortages, life circumstances, and economic factors made caring for furry family members more challenging. We had 710 owner relinquishments and 250 pet pantry uses, but we also connected 2,022 animals with their new families through adoptions and had 375 willing foster families assist us in the care of our younger, more vulnerable animals. While veterinary clinics reduced hours or shut down completely, we were able to see over 800 new clients, administer more than 13,000 vaccines, perform over 6,500 spays and neuters either in the clinic or on the Neuter Scooter. Additionally, we provided specialty surgeries and dental procedures. We opened our doors wider to grant access to our community of animal lovers that so desperately needed help.


The VBSPCA's impact felt more meaningful this year and cannot be captured by numbers alone. The impact was felt in the relief of a pet owner receiving aid or care; the joy of an adopter finding their one true companion; the willingness of the 487 active volunteers helping us to complete long overdue projects or support operations; the happiness of the youth who returned for humane education learning opportunities; the generosity of our donors attending our spring gala or fall golf tournament; and the rewarding exhaustion of our teams after longer days with more animals. This is the impact that continues to define us, and it breathes life into each new day as the challenges become opportunities to make a difference in the lives of the animals and the people we serve.

As we lean into the work of the new year, we are filled with optimism brought from the lessons of the past. We begin the year with a major clinic renovation to grant even greater access to affordable veterinary services, made possible by our PetSmart Charities Accelerator grant and our friends at Taylor Construction. Being "under construction" but still operational will be a challenge in itself. We look forward to another successful celebration at our Wags and Whiskers Gala this spring with 450 of our animal loving friends. With the theme of Sunset Speakeasy, it is sure to be an event that can't be missed! And we continue our collaboration with local partners in Virginia Beach and Hampton Roads to discover more solutions for ending animal suffering.

As 2023 taught us so much about flexibility, innovation, and empathy, 2024 can only continue to carry the promise of better tomorrows. We are indebted to you for your part in keeping us not only sustainable, but winning.

In January, PetSmart Charities awarded the VBSPCA Clinic \$200,000 to expand access to affordable veterinary care. The grant provided increased clinic staffing and additional medical equipment.

Two VBSPCA puppies participated in Animal Planet's Puppy Bowl in February. Espresso represented Team Fluff while Briscoe earned a spot on Team Ruff, shining a light on our shelter and adoptable animals everywhere.


Four kittens who were victims of animal cruelty received second chances. Each was missing a paw and needed specialized surgery and care. Clover, the last of the kittens to be adopted, went home in March.

More than 400 animal lovers gathered for the VBSPCA Wags & Whiskers Gala on April 29th. The event featured a Havana Nights theme and raised more than \$340,000 in critical funding.

We joined 8 other local shelters at PETA's Poochella Adoption Fest. Bella, a 13-year-old Shih-Tzu who had been at the VBSPCA Shelter for 3 months, was adopted thanks to the event!

The VBSPCA was part of the inaugural BEACH IT! Country Music Festival in June. Miranda Lambert's MuttNation Foundation organized a donation drive where some of our canines met their new families.





In July, senior dogs got a leg up from The Grey Muzzle Organization with a \$10,000 grant. The funds provide medical care, helping dogs like 16-year-old Sampson find their forever homes faster.

August began with the first of two transfers organized by the Bissell Pet Foundation as we welcomed 24 canines from Louisiana. In October, another 23 dogs arrived from the Midwest.

The VBSPCA Memorial Garden officially reopened on September 17th following a major revitalization effort. It features a shady walkway for shelter dogs, a relaxing waiting area for clinic clients, and an expanded memorial garden.

VBSPCA Puttin' for Paws Charity Golf Tournament raised more than \$54,000. Then dozens of dogs and their people donned their costumes for the VBSPCA Howl-O-Ween Pub Crawl.

In November, we started offering youth shelter tours once again. This was an important first step as we expand our Humane Education Program in 2024 and beyond.

Home for the Holidays returned for its 15th year in Hampton Roads thanks to our partners at Priority Automotive. 323 animals were adopted from participating shelters in December, including 109 VBSPCA animals.



2024 FUNDING PRIORITIES

1. Clinic Expansion

With the recent veterinary shortage and the increasing need for accessible, affordable care for the pets in our community, clinic expansion is a top priority for 2024. This effort will also improve medical care for shelter residents. A major clinic renovation will begin in early 2024, funded by the PetSmart Charities Accelerator grant. We will add surgery, treatment, and exam room spaces to better serve the clients and pets that need us most. The grant is spread over 3 years with the initial buildout in the first half of 2024 and will increase operations; talent retention and acquisition; and equipment updates to enhance and improve our level of veterinary care.

2. Shelter Operations Expertise

As we manage a robust shelter population at all times, we strive to continue to build quality leadership with the necessary animal welfare expertise. Our shelter management and staffing excels in animal care and enrichment, which are talents that we want to continue to build. Investments in continuing education, merit increases in compensation, and career pathing will be critical to team success and beneficial for the animals.

3. Culture Initiatives

We define our culture as professional and positive. We want to manifest that through leadership training; diversity, equity, and inclusion initiatives; associate rewards and recognition; increased volunteer engagement;

cross-team collaboration; and work/life balance efforts. Our Executive Team will continue to enforce team building activities to emphasize these values and our culture.

4. Community Engagement

One of our core values is community, meaning that we are an integral and critical partner in animal welfare throughout Hampton Roads. We want to stay keenly focused on the impact that we have on our community through transfers of animals to optimize adoptions; sharing of shelter best practices and resources; providing quality veterinary care to other partners when needed; or collaborating on initiatives that further our mission of compassion. By working together with other animal welfare and human service organizations, we can improve the overall mental and emotional health of the public we serve.


5. Humane Education

In late 2023, we reinstated staffing in our humane education department and we plan to evolve programming with our area youth and schools in 2024. We will offer in-person programs including shelter tours, activities, and animal interactions; in-school options such as Listening Ears; and service learning projects. We will continue to offer virtual opportunities as well as teach our youngest animal ambassadors kindness, respect, and empathy. A strong pillar of our mission prior to the pandemic, we are determined to rebuild this foundational programming.

CLINIC EXPANSION *Now Underway*

On January 15th, construction began on a major renovation of the clinic designed to increase its capacity as well as provide for additional staffing and equipment upgrades. The project is funded by the PetSmart Charities Accelerator grant and will provide greater access to low-cost veterinary care including urgent care services, case management of long-term health issues, and everyday wellness and illness visits.

The clinic is a vital resource for both the community and VBSPCA shelter animals, and we look forward to providing low-cost, quality care for more animals in Hampton Roads. The renovations are expected to be completed by July 2024.
